

Terms and Conditions for the MBA Bursary for May 2024 intake

This offers 20% - 25% bursary of the total fee for MBA programme offered at Heriot-Watt University Malaysia (“HWUM”). The bursary is applicable only for May 2024 intake.

1. Applicants must submit a complete and accurate application to HWUM and pay RM500 for Registration Fee together with the full 1st semester tuition fee of the MBA programme applied by the respective deadline to be eligible for the bursary.
2. Please refer to table below for 1st semester tuition fee payment deadline. No bursary will be granted after the deadline.

3. The bursary is applicable to the entire tuition fee of the programme and applicants must be enrolled as a full-time or part-time student for the entire length of the programme, register for all courses and complete the programme within the original time frame as stated in the offer letter.
4. The bursary is awarded in the form of a tuition fee waiver only. It does not cover any other charges of fees such as resitting of examination fee, extension of studies fee, etc.
5. For the avoidance of doubt, applicants must pay full tuition fee at the 1st semester (3 modules) full-time or part-time MBA programme. The bursary from the 1st semester will be waived in the subsequent semester and the bursary continues till completion of the programme.
**Please see the scenarios below as illustration of the bursary waived.*
6. Applicants are entitled to only ONE type of bursary at any one-time including sponsorship from other institutions / bodies. The one with the highest quantum will automatically apply.
7. The bursary will not be granted for applicants with Early Bird Waiver, Family Discount, Alumni Discount, Professional Bodies Bursary, Heriot-Watt Corporate Partnership Postgraduate Bursary, or industry sponsored scholarship.
8. The bursary is neither transferable nor exchangeable for cash or other alternatives.
9. The bursary is only applicable for study at HWUM, and it is not transferable to other HWU campuses or locations.
10. The bursary is forfeited in the case of deferment or withdrawal of studies.
11. In case of application withdrawal and refund request, the bursary waived is not refundable. The following is an extract of the refund policy for reference:

Refund policy

- a. The Registration Fee and Visa Application Fee are not refundable under any circumstances.
 - b. Subject to sub paragraph (a), if a student provides notice more than 2 weeks before the commencement of the semester, 100% of the tuition fees paid may be refundable.
 - c. Subject to sub paragraph (a), if a student provides notice within 2 weeks before the commencement of the semester, 50% of the tuition fees paid may be refundable.
 - d. Subject to sub paragraph (a), if a student provides notice within 2 weeks after the commencement of the semester, 50% of the tuition fees paid may be refundable.
 - e. No fees are refundable 2 weeks after the commencement of the semester.
12. Notwithstanding anything to the contrary, the bursary is granted at the sole discretion of HWUM. HWUM reserves the right to change the bursary structure or terminate the bursary at any time at its discretion. In the event of termination by HWUM, the applicant will be liable to pay for the tuition fees for the balance of the MBA program.
13. HWUM reserves the right to make any amendment to the terms and conditions herein and will use its best efforts to inform the eligible students accordingly.
